

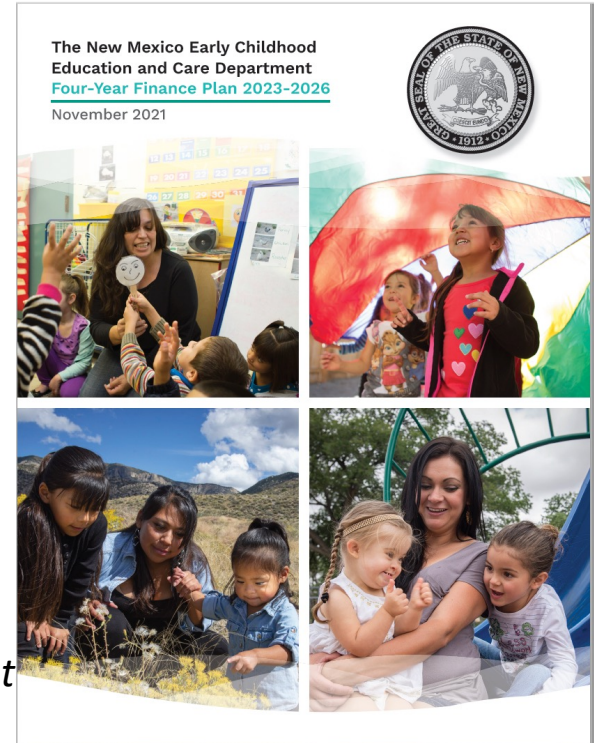

Systems Modeling

New Mexico System Building Response

- Comprehensive system wide approach
- Pieces of this approach:
 - Child care Revenue and Expense Model
 - Home Visiting Cost Model
 - System Revenue and Expense Model
 - System Action Plan
 - Funding to work on this approach

Legislatively mandated Finance report served as an opportunity to system change.



New Mexico Response: Change In Action

Child Care Model

- Child Care Model
- Changed rates to address inequity in funding family child care
- Increased infant and toddler rates to cover cost of care
- Increased compensation levels used

Home Visiting Model

- Increased rates paid for home visiting services by 50%
- Used model to address inequities in Medicaid rate setting across HV types

Systems Model

- Supported increase in child care eligibility ceiling and elimination of parent co-pays
- Budget and planning for use of Trust driven by quality, access and associated infrastructure needs for the system
- PreK expansion informed by modeling on increased compensation and quality levels



Detroit

System models include activities that happen *outside of direct service providers* to support the citywide ecosystem of early learning and care.

Examples:

- Informational campaigns and materials
- Data systems used across providers
- Training and professional development
- Quality evaluation and improvement
- System-wide capital investments

Some activities can be either a direct service cost or a system cost, depending on how they are organized and paid for. Examples: Coaching for providers, enrollment systems



Detroit's System Model

System Component	Current initiatives
Quality improvement activities	Early Childhood Support Network, Brightmoor Quality Initiative, related programs
Family information, navigation, and coordinated enrollment	Connect for Care Kids platform (United Way), Great Start Collaborative
Facilities renovation and construction	IFF support for new construction and renovation
System coordination and advocacy	Hope Starts Here, Mayor's Office of Early Learning
Wraparound services	Basic needs grants; Kresge Foundation cohort providing art/music, nutrition, parent engagement, and other support for ECE programs; Kids Health Connection providing fitness and health programs
Business supports for providers	Partnership with Detroit Economic Growth Corporation
Workforce development	Partnership with Detroit at Work on recruitment and funding of CDA certification, retention bonuses

Place Based Initiatives

1. **BEST (Birth Through Eight Strategy for Tulsa)**

System of care approach that:

- a. incorporates integrated data system
- b. coordination between home visiting programs
- c. partnerships between non-profits and county agencies
- d. Incorporates parent voice to help make decisions

2. **Ready for School, Ready for Life (Prenatal to Five-Guilford County, NC)**

System of care approach that:

- a. incorporates integrated data system
- b. key focus areas of language/comm, physical, social emotional, cognitive, approaches to learning
- c. partnerships between public and private stakeholders
- d. usage of policy to help drive other activities
